CourtNotify is a cloud-based subpoena management solution that automates the process of subpoena issuance and receipt for officers and civilian witnesses. It can be used as a stand-alone law enforcement system or integrated with judicial case management systems to provide an end-to-end solution for the courts, prosecutors, public defenders, officers and civilian witnesses.

Clerks add witnesses to case events and send subpoena notifications electronically to officers or civilian service deputies. Officers' schedules can be viewed in real-time. Time-stamped notice delivery and receipt acknowledgements support witness accountability. It's an ideal means of monitoring notifications as part of a court case's progression.

When *CourtNotify* is used by law enforcement agencies, case details can be imported from case management systems or entered manually.

Officers receive notifications via their *CourtNotify* account, agency email, and mobile devices.. Embedded acknowledgment links enable quick time/date stamped receipt verification.

Serving agencies use the *CourtNotify* solution to receive civilian subpoenas electronically and assign deliveries to service deputies. Delivery results can be saved using bar code scanners or entered manually. All deliveries results can be viewed online in real-time by court clerks, prosecutors, defense attorneys and law enforcement.
