hoc OT assignments. Administrative
tasks can be achieved, such as viewing
agency announcements or routing
their timesheets for approval.

Supervisors can quickly search for and call other employees to backfill vacancies. Employee requests can be reviewed and responded to in real-time. Special events can be assigned individually or in bulk. Employee's time worked can be authorized for payroll processing.

When used with CourtNotify, officers receive their court notifications with logistical and defendant information in real-time. Once received, easy confirmation acknowledgments are saved and viewed by all CourtNotify users. Geofencing can be used to track courthouse check ins/outs by officers.





Authorized Control

- » Usage authorization controlled by authorized agency personnel
- » Enables agency to add, remove and/or return personnel to mobile usage
- » App downloaded via iTunes (IOS) and Google Play Station (Android)

Fast Mobile Data Returns with Reduced Security Risks

- » Uses Microsoft Azure Government Services with no personnel data saved in the cloud
- » Only housed data is a mobile user name, password, and agency code
- » All other data processed but not stored
