The Orion Mobile apps provide registered users the convenience of Android or IOS mobile access to their *CourtNotify* or *Workforce Management PLUS* account. As a result, employees can quickly complete scheduling and administrative tasks on the go.

When used with *CourtNotify*, public safety witnesses receive court notifications in real-time. Once received, easy confirmation acknowledgments can be saved and viewed by all *CourtNotify* users. Time-off requests can be made and responded to by supervisors in real-time. Officer's montly or weekly calendar views include scheduled court dates that are coordinated with their shifts and approved events. Each case notification includes logistical details and defendant information for better clarity.

When used with Workforce Management PLUS, public safety witnesses have the same capabilities, plus the ability to enter overtime and shift swap requests. Personnel can quickly view and sign up for off-duty or special events -- or they can volunteer for ad hoc overtime assignments. Agency announcements or specific notices such as shift-related BOLO's or CAD incidents, can be viewed by individual employees or targeted groups.

Supervisors can quickly search for and call other employees to backfill vacancies. Employee requests can be review and responded to in real-time. Off-duty and special events can be assigned individually or in bulk. Employee's time worked can be authorized for payroll procssing. It's ideal for personnel on the go.

> AUTHORIZATION CONTROL

The Orion Mobile Apps can be downloaded through iTunes and Google Play Station. Usage authorization is controlled by authorized agency personnel. This allows admins to add, remove and/or returned personnel to mobile usage.
